Amendments & Recommendations

Chapter Presidents, Recording Secretaries and Bylaws Committee Members,

Remember that all chapters bylaws, standing rules and policies are due by March 10, 2019, to Marty Billing, OSC Vice President. If you haven't done so already, now is the time to check your chapter bylaws, standing rules and chapter policies against the following:

- Read through the 2018 Review of Chapter Bylaws and Standing Rules and cover letter mailed to your chapter president last summer and implement the suggested changes and recommendations.
- Use the 2018-2019 Sample Bylaws document posted on the Ohio P.E.O. web site as a guide (ohiopeo.org > Chapter Resources > Forms/References) as well as the Style Guide found on the P.E.O. International website (peointernational.org, then type "style guide" in the Search box). Both are excellent resources.

Once the recommended changes have been made:

- Report the changes that were made to the chapter's bylaws at the next business meeting. The new date on the bylaws is the date of the meeting at which you are reporting.
- If you are adding or making changes to your bylaws, standing rules, or policies other than what A&R has recommended, be sure to follow the procedure found in Article V (or VI) of your chapter bylaws.

- The recording secretary then attaches the new bylaws to the minutes of the meeting at which they are read and gives a copy to the president for the President's Book. The recording secretary replaces the previous bylaws in the front of the Recording Secretary's Book. If the chapter's yearbook contains the bylaws, be sure that the yearbook committee has a current copy.
- Please highlight all changes made to your bylaws before submitting them. Various forms of highlighting include the use of a highlighter, different ink color, italics, bold, or underlining. If no changes were made, it is important that you still submit a copy with "No Changes" written at the top of the document.

Even if no changes were made your chapter bylaws, standing rules, and chapter policies are due to Marty Billing, OSC Vice President, by March 10, 2019. The deadline for Ohio Scholarships is fast approaching! The Committee is eagerly awaiting your applications. Remember that all applications must be postmarked or emailed by February 1, 2019. By now your chapter has interviewed excellent candidates, written descriptive chapter recommendation letters, and encouraged your applicant to write a personal essay that will help the Ohio Scholarships committee get to know her. All are inspired to "Light Tomorrow" with these wonderful candidates and their bright futures!

Please access the checklists on the Ohio P.E.O. website to assist your chapter and candidate in completing all requirements for the application. All Ohio Scholarships documents on the website have been revised, so please read all documents completely, as instructions have changed.

Your cooperation with the new requirement that applications **must be typed** is greatly appreciated. This is to ensure that all applications are legible. Your diligence with checking all areas of the application before submission is also required. This reduces the amount of errors and incomplete applications, which cannot be accepted.

Please consider submitting your candidate's application electronically. All instructions can be found under *Instructions to Sponsoring Chapters: Electronic Submission*. If your chapter chooses to submit the application packet by mail, please refer to the *Instructions to Sponsoring Chapter: Mailed Submission*.

Encourage your chapter to give generously to Ohio Scholarships this year! The fund is supported solely by gifts from Ohio P.E.O. chapters and individual members. Chapter donations may be sent directly to Beth Cox, the assistant to the treasurer of Ohio State Chapter, using the Chapter Gift Transmittal form. Educational Loan Fund

During my short tenure as the ELF Chairman, I have received several questions about how chapters can find more women to sponsor for the Educational Loan Fund. I can understand that chapters may want to find candidates for the other "non-loan" projects, thinking that many women would prefer a scholarship or grant over a loan. But ELF may be worth consideration, since, statistically speaking, 70% of all college students are taking out some sort of education loan. The average interest rate for many loans is anywhere from 4.8%-7.44%, depending on the type of loan.

Do you know what the current interest rate is on the ELF loan? It is only 2%!

So, back to the question, how do we find more candidates?

• If you sponsored a woman for another project and she was not selected, she may be interested in the Educational Loan Fund.

- Reach out to your community college to see if they provide information on loans to their students.
- Talk about ELF to anyone who knows women who are in college working toward an undergraduate degree, graduate degree or doctoral degree. Some highlights on ELF: The maximum loan amount is \$12,000 for associate and bachelor's degree programs; \$15,000 for master's degrees; and \$20,000 for doctoral-level degrees. All applicants for the ELF program must be sponsored by a local P.E.O. chapter.

Sisters, I dare you to do a simple internet search on the amount of debt that students are handling these days, specifically women. Spread the word that ELF is available for women needing financial assistance to help them achieve their educational goals.

Program for Continuing Education

PCE is 45 years strong and has seen tremendous growth in the number of women needing financial assistance after their education has been interrupted. As noted in the latest edition of the PCE newsletter, women's workforce is changing with a larger number of women unable to compete for promotions or even maintain their current employment without a higher degree or advanced certification. This in turn drives the need for grants even higher. You may read the entire article as well as 7 *Tips for PCE Success* by accessing this newsletter and previous editions on the International website.

Ohio chapters continue their exemplary support of PCE both by contributing funds and sponsoring applicants. Since March 1, 2018, grants in the amount of \$42,000 have been awarded to 22 recipients sponsored by 20 Ohio chapters. This amazing number is made possible by each and every sister continuing to search for applicants who could be anywhere including your grocery store, local library, favorite restaurant, bank, etc. Keep up the good work, Ohio chapters!

A "PCE Information Card" is available in PDF format on the International website. Consider printing this card as a convenient handout for potential applicants. The opening paragraph states: "P.E.O. Program for Continuing Education, established in 1973, is a need-based grant program providing one-time financial assistance to women whose education has been interrupted and who find it necessary to return to school to complete a degree or certification that will improve their marketable skills for employment to support themselves and/or their families." A great start in your search for that eligible applicant!
