OHIO'S MASS GATHERING ORDER

Mass gatherings in Ohio remain limited to 10 people.

- Gatherings at a household or family residence should be limited to close friends and family and are recommended to be 10 visitors or less.
- Residents in a red or purple county, as designated by the Ohio Public Health Advisory System, should limit hosting or attending gatherings of any size.
- Wear a mask at all times at gatherings and maintain physical distance.
- High-risk individuals should take extra precautions to limit the number of people they interact with.
- Make the group of people you interact with most often as small as possible and make sure that they are taking appropriate COVID-19 precautions – even if you are just gathering with family friends or neighbors at your home.

Bylaws and standing rules may not elicit shrieks of joy, but they **are** what keep our P.E.O. chapters current and compatible with all other chapters. Your policies define your chapter's personality and create your history. . . PLUS the Ohio State Chapter has given you a "cheat sheet." Check out the Sample Bylaws on the Ohio P.E.O. website and check the number of meetings, dues, reciprocity dues if applicable, standing committees, and policies on **your** chapter's bylaws for accuracy. The website even gives you samples of wording and policy suggestions. Maybe your bylaws committee would like to suggest some changes or updates. If so, your chapter will have time to vote on these before the **March 10, 2021** due date.

One more reminder – chapters wishing to propose an amendment to the Ohio State Chapter Bylaws & Standing Rules must submit proposed amendments in writing to the chairman by December 31, 2020. You should have received a letter regarding this in the September 1st Board Contact Letter.

Scholar Awards

In 2008, Johanna Schneider was a P.E.O. Scholar Award winner. In 2020, Dr. Schneider is working at the National Institute of Health with Dr. Anthony Fauci and is on the team that wrote the COVID-19 Strategic Plan.

When local chapters nominate a woman for the Scholar Award (PSA), they can never accurately predict how far she will go in her chosen career. But chapters recognize excellence when they see it! A local chapter that sponsors a deserving PSA candidate helps her *Dream and Take Flight*. Find your outstanding candidate by contacting university graduate offices, listening to conversations about exemplary daughters, granddaughters, nieces or neighbors, or following up with women who initiate contact with P.E.O. and are referred to your chapter.

Eligibility requirements are on the P.E.O. website. Components of the application process include a chapter interview with the prospective candidate, checking that the candidate answers all questions on the application, and gathering information that makes the nomination letter reflect the personality and passion of the candidate. See P.E.O. *Tips for Writing a PSA Nomination Letter*.

Chapters may submit a nomination between August 20 - November 20, 2020. This year the stakes are higher than ever! There will again be 100 women selected and the award is now \$20,000. The monetary increase has been made possible by additional donations to PSA. Ohio Laureate Chapters (those who donate at least \$500) increased from 21 chapters a year ago to 42 chapters in 2019-20!

Together, we can make a real difference in the lives of women. Let's find some special ones and help them *Dream and Take Flight*.

P.E.O. International Peace Scholarship

Carl Sandburg, American poet, once said, "Nothing happens unless first a dream." P.E.O. created our very own dream-making and world-changing scholarship with the creation of the International Peace Scholarship (IPS) in 1949. IPS was created to help women from around the world to follow their dreams and take flight in the achievement of their educational goals. These women aim to return to their home and use their education and advanced degrees to make the world a better place. Since 1949, IPS has awarded scholarships to 6,240 women from 178 different countries totaling over 42 million dollars.

How can you help these women take flight and make their dreams a reality? Share more about IPS with your local chapter and community:

- Spread the Word! Share IPS information and requirements with local universities that offer advanced degrees.
- Take a Minute! The P.E.O. International website shares the experiences of scholarship recipients every other month. It only "takes a minute" to share this with your local chapter at meetings and it's so exciting and humbling to hear what these young women have to say.
- Moment for Peace! Also available on the website, this is a document of names and bios of our scholarship recipients. This gives more information and background, in addition to some words from some of the women. This document is added annually.
- Partners in Peace! Lastly, YOU can become a Partner in Peace. A minimum donation of \$500 to the IPS Fund and completed Partners in Peace form (found on the International website) should be submitted to your state treasurer by January 31st. Your local chapter will be matched with an IPS recipient that you can get to know a little better.

I encourage your local chapter IPS chairman to check the website regularly. Let's *Dream and Take Flight* in action to help women all around the world!

Now is the time to start searching for your STAR candidates! Chapter recommendation forms must be submitted by OCTOBER 15! While it is a challenging time to navigate because of limitations imposed due to the global pandemic, there are students shining brightly through it all. Get creative in searching for your candidates and then take the time to get to know them using Zoom, Skype, or Google Duo!

If you are having trouble making connections this year, consider reaching out to previous nominees or recipients to see if they have recommendations of candidates. Other ideas for finding your ideal candidate include reaching out to community leaders, local churches, Girl Scout troops, United Way, or other community service organizations. You can also reach out to high school guidance counselors. While schools may not be in session in person, they are still connecting with their students and can recommend worthy applicants. Last year there were 2,282 applications submitted with a total of 880 recipients selected. This brings the total number of recipients to 5,214 over the past twelve years. The total amount awarded thus far is \$13,035,000!

Remember that your chapter can donate \$2,500 for a Named STAR Scholarship. The funds designated for this must be received by the P.E.O. Executive Office in Des Moines by December 1st. On the transmittal form, have your treasurer note that the funds are for a named scholarship and the name of the person being honored or remembered. Also, don't forget the deadline of January 31, 2021 for the \$500 STAR Constellation donations. Last year there were 1,068 local chapters that became STAR Constellation contributors!

We look forward to seeing Ohio's upcoming STARs in 2021!

A TIME TO DREAM...

Calling all dreamers to apply! The Ohio Scholarships application material is on the state website. You know the drill – go to it, chapters! If your chapter is new to supporting a candidate, please visit <u>www.</u> <u>ohiopeo.org</u>, go to the Projects tab, then down to Ohio Scholarships. There are four forms essential to the process. Two additional forms are helpful resources. We had 73 chapters sponsor applicants last year. We are dreaming for more chapters to be involved this year.

Calling all dreamers for funds! The award monies for Ohio Scholarships come from Ohio only. We know this is a critical year with Covid-19 limiting our fundraising. We know we need to support our six outstanding international scholarships. It will be critical to remember Ohio Scholarships needs our funding as well. The more funds we have, the more awards we may be able to give. (We awarded \$98,465 this spring!) From 2016 through 2020 the amount of awarded OS funds has increased yearly. We are dreaming for this trend to continue.

Calling all dreamers to be realists, too! "Visionaries can teach us to dream. Realists can teach us to accomplish."* There are realities that need to be addressed. **We are unable to extend the deadline**, so early submission is strongly encouraged for both electronic and mailed submissions. There have been unfortunate complications with applications mailed via USPS. Mailed applications must be postmarked by Feb. 1. The committee must receive packets by Feb. 8. That allows USPS one full week to complete its job. A notification of receipt is sent to chapters when applications (both electronic and mailed) arrive. For mailed applications, call the OS chairman within 10 days if you have not received confirmation of receipt.
