### Scholar Awards

So often in our society there is focus on winners and losers. As P.E.O.s, we have to be careful not to fall into this mindset. It won't be much longer before the 2020 Scholar Awards are announced and although there will only be 100 chosen from the 928 nominations, all of the nominees are already winners!

Recipients and their sponsoring chapters will be contacted by May 1. Sponsoring chapters should reach out to those not selected in addition to those who are. This \$15,000 award is certainly prestigious and all who were nominated are highly talented young women. If your nominee is not selected, investigate whether she will be eligible next year. If she is early in her graduate program, this extra year could give her additional time to grow professionally and add to her scholarly activities, presentations, publications or leadership opportunities. This might help her become a more qualified candidate next year.

Another way for chapters to help women not selected this year is to sponsor her for an ELF loan. While it would be a loan rather than a grant, she is probably eligible for the maximum \$15,000 loan. Two years ago my chapter unsuccessfully nominated a PSA candidate but then followed it up by successfully helping her secure a \$15,000 ELF loan.

Chapters can also reach out to all PSA candidates by inviting them to meetings or social events or even consider them for membership. Simply because they did not "win" the PSA this year, they are certainly not "losers." I know that our Founders believed that "loving concern" extended beyond the official bonds of sisterhood.

### **Educational Loan Fund**

Hear Ye! Hear Ye! Hear Ye! The sisters of the Ohio State Chapter of P.E.O. have officially started to "SWING INTO 2020 WITH THE STAR"! Let's honor the past history of the Educational Loan Fund (ELF) so that we can continue to thrive in this new decade.

Funds to start ELF came from P.E.O. Day at the 1904 St. Louis Exposition, with the first ELF loan granted in 1907 to Edna Pickering, a student at Iowa State Normal School, in the amount of \$300 (approximately \$8,000 today). By 1919, the ELF Fund grew to over \$100,000 and then by 1923 to over \$200,000. A total of 1,875 loans were granted in ELF's first twenty years. According to the P.E.O. Educational Loan Fund 2019 Statistical Report, loans totaling \$213,549,209 have been approved to 48,907 women in the United States and Canada to help them attain their goals in higher education! There are 3 loan amounts available:

- ▶ \$12,000- associate and bachelor degrees, technical or professional programs
- ▶ \$15,000- master's degrees
- ▶ \$20,000- doctoral degrees

Funds available for loans are always changing and can be affected by the number of new loans granted, loan repayments received, and contributions from chapters and individuals. Ohio Chapters contributed \$44,441 in contributions for the year ending June 30, 2019, with 24 loans approved for \$308,500 in that same time period.

The number of chapter recommendations and applications continues to increase due to the efforts of our local chapters as well as through updated policies governing ELF loans that make this 2% loan so attractive. An important update that starts with loans processed on January 20, 2020 provides a six-month grace period following the borrower's stated graduation date, with no interest accrued and no payments required. After this grace period equal installments of combined principal and interest begin.

Let's continue to make history and share this new information with women pursuing their educational dreams!

### **UN/NR** Committee

Help! A chapter sister is moving! What should we do?!

After Phone Every One, there is a flurry of activity to correct contact information for sisters who have moved. If you are unsure of what to do when a sister moves away from your chapter (becoming a nonresident member), here is a short list of steps to be taken (a detailed list is in the Membership Toolbox at the P.E.O. website):

- 1) Before she moves, visit or contact your sister to obtain her new contact information, the date she moves, and complete the Notice of Member in Your Area form with her. Consider giving a recognition pin or other gift.
- 2) Provide your sister with P.E.O. International brochure, Guide for an Unaffiliate, and be sure she has her current P.E.O. Membership card.
- 3) When the moving date arrives, the corresponding secretary completes the online Change in Membership form at <a href="https://www.peointernational.org">www.peointernational.org</a> with her new information. (Note: if a confirmation email is not received, the changes were not properly submitted.)
- 4) The corresponding secretary should mail copies of the completed Notice of Member in Your Area form to each chapter/reciprocity/state organizer in the area of your sister's new home. Address information is available at the P.E.O. website under: *Resource Library/Listings & Directories*.
- 5) Stay in touch with your sister with cards and/or calls every few weeks/months to be sure chapters contact her. If not, please **resend** the Notice of Member in Your Area form, and contact the UN/NR Committee and/or state organizer for help.
- 6) Once your sister transfers to her new chapter, send congratulatory greetings to her and to her new chapter!

Please make sure the contact information for each of your chapter's nonresident sisters is accurate so that your sister can easily SWING INTO 2020 WITH THE STAR!

According to Wikipedia, continuing education is "an all-encompassing term within a broad list of post-secondary learning activities and programs." Certain colleges and universities began their continuing education programs in the early part of the 1900s. These days more and more adults are finding it necessary to return to school to get further education to support themselves and their families. This is where our Program for Continuing Education grants come in for women in this position.

Continuing education does not apply only to a bachelor's degree, but also to associate degrees, master's degrees, and technical programs. A six month technical program, or an associate degree can increase someone's weekly pay by \$40 or more. Our program is helpful in assisting a growing number of single mothers. According to the U.S. Census Bureau, between 1960 and 2016, the percent of children living with a single mother increased from 8 to 23 percent! Studies show that earnings for single mothers have dropped significantly in the past two decades. For women, and single mothers in particular, obtaining further education leads to higher wages, better benefits, and more stability for their families.

As your chapter looks for applicants for the PCE, remember that it is available not only to those women seeking traditional college degrees, but also to those obtaining technical training. The award can be used for tuition, books, transportation costs, uniforms, testing fees, and other equipment. As there are rolling deadlines for the grants, you can be seeking candidates throughout the year.
