#### TAKE FLIGHT aboard OSA --Ohio Scholarships Airways

How to have a successful flight --

**STEP 1**: Double check your boarding pass, passport, carry-ons and baggage. For OS purposes, this means: has your applicant completed *all* sections of the application? Forgetting something for a trip can create problems. Forgetting something or having an out-of-date passport can abruptly end a trip. This is true for the applications. Are all materials up-to-date? Current transcript? No out-of-date expired information? Has everything been submitted for a complete application packet? We want successful flights and do not want to miss an opportunity to travel because of overlooked necessary travel details.

**STEP 2**: Arrive on time at the airport, which means two hours early for flight departures. For OS purposes, this means getting applications submitted in a timely manner. We are unable to extend the deadline; early submission is strongly encouraged for both electronic and mailed submissions. There have been unfortunate complications with applications mailed via USPS. Mailed applications must be postmarked by Feb. 1 and received by Feb. 8. That allows USPS one full week to complete its job. A notification of receipt is sent to chapters when applications (both electronic and mailed) arrive. For mailed applications, call the OS chair within 10 days if you have not received confirmation of receipt. Further, keep a copy of all travel documents. Copy any materials you submit in the event of a turbulent flight, in the event that materials need to be resubmitted.

**STEP 3**: Enjoy the flight. Dream of your destination. Sit back, nibble, sip in-flight refreshments (well, pre-Covid they were nicer). Hope for the best possible outcome for this flight – that your applicant may receive funds!

### **Educational Loan Fund**

International Chapter notes that loans approved for ELF drastically decreased mid-March from the norm of one million in loans approved monthly. It is no wonder! Chapters were unable to meet in person and it took most of us some time to adopt the technology that enabled regular chapter business to proceed. Obstacles for potential recipients must have seemed overwhelming as well.

Imagine how it must feel to have Covid-19 appear out of nowhere, blocking the path to your educational dreams. Colleges and universities are shuttered, offering a limited curriculum online for new and enrolled students. SAT and ACT testing sites are closed, campus visitations are halted and graduations delayed. Maybe that waitress job with lucrative tips disappeared and with it the funds to help meet those goals. Even more drastic, what if that middle-class family lost its financial security, joining the long food distribution lines we have seen in Ohio?

We can help. The maximum loan amount for a nondegree accredited program, an associate or bachelor's degree is \$12,000; for a master's degree, \$15,000; for a doctoral degree, \$20,000. These loans have a 2% interest rate and repayment doesn't start until six months after graduation. Of course, finding qualified women for your chapter to sponsor is the critical first step. The steps chapters should take are detailed on the P.E.O. International website.

Chapters might also consider becoming an ELF Legacy Chapter by giving a lump sum gift of \$500 to ELF this fiscal year, creating additional funds to meet the need.

The good news is that applications increased in April and by August, ELF was back to normal, granting more than one million dollars in loan approvals to help those dreams to take flight.

### **Amendments and Recommendations Committee**

#### To all Chapter Presidents, Recording Secretaries and Bylaws Committee Members,

Though we are all praying for pre-pandemic normalcy, our chapter meetings are still following procedures established by P.E.O. International during Covid-19. Please keep this in mind so that you can easily prepare your bylaws by the **March 10, 2021** due date.

All chapters' bylaws, standing rules and chapter policies will soon be due. If your chapter has not done so already, **now** is the time to check your chapter bylaws, standing rules and chapter policies and check them against the following:

- Read through the 2020 Review of Chapter Bylaws and Standing Rules and cover letter mailed to your chapter president last summer and implement the suggested changes and recommendations.
- ✓ Use the Suggested Bylaws posted on the Ohio P.E.O. Website as a guide as well as The Style Guide (found on the P.E.O. International website).

Once the recommended changes have been made:

- Report the changes that were made to the chapter's bylaws at the next business meeting. The new date on the bylaws is the date of the meeting at which the changes were voted upon.
- ✓ If you are adding or making changes to your bylaws, standing rules, or policies which require a chapter vote, be sure to follow the procedure found in Article V (or VI) of your chapter bylaws.
- ✓ The recording secretary then attaches the new bylaws to the minutes of the meeting at which they are read and gives a copy to the president for the President's Book. The recording secretary replaces the previous bylaws in the front of the Recording Secretary's Book. If the chapter's yearbook contains the bylaws, be sure that the yearbook committee has a current copy.

✓ Please remember to highlight all changes made to your bylaws before submitting them. Various forms of highlighting include the use of a highlighter, different ink color, italics, bold or underlining. If no changes were made, please indicate that at the top of the document.

Your chapter bylaws, standing rules and chapter policies are due to Jan Hornack, OSC Vice President, by **March 10, 2021**. Please email your bylaws as a Word document (jan.hornack.peo@ <u>gmail.com</u>). However, mailed copies will be accepted. If you have any questions, please contact us. Note that Sheryl's email address has changed.)

#### Our Ohio Suite at Cottey College

As many of you are aware, there are suites in the Cottey dormitories that are supported by many P.E.O. states/ provinces/districts. There are two obligations that come with supporting a suite: provide financial support to 1) maintain/ refurnish the common area and 2) refurnish the bedrooms. In 2017 the endowment fund for the common area was short of the amount needed, but due to the generous donations received at the 2017 Convention, the Ohio Suite Endowment Fund is now fully funded. This fund is held by Cottey College to be used when needed, but only for the common area. The bedroom furniture is replaced at least every 15 years, and it is time for replacing the furniture. The suite can accommodate ten students, and the furniture is \$1,500 per set/student. In the past, chapters generously gave voluntary donations to the Sue Baker Fund and Sesquicentennial Fund. On the 2021 Annual Dues Report of Treasurer of Local Chapter, an "Optional Donation to Ohio Suite, Cottey College" has been added, with a suggested donation of \$3.00 per active member. Since the delegate fee has been reduced to \$75 due to having a virtual convention, it is hoped that the chapters will consider this donation to cover the cost of replacing the student furnishings and help make the Ohio Suite a comfortable place for these young women to live. Thank you in advance for your consideration and for any donation you may make.

## From the Cottey College Office of Institutional Advancement . . .

Charles Dickens began his classic, A Tale of Two Cities, with the words, "It was the best of times, it was the worst of times..." The words that Dickens wrote in 1859 might also describe some of what we experienced in 2020. The year began with great promise – enrollment was up; new programs had been added; students and faculty were researching, publishing, and presenting; the Cottey Comets were winning; and fundraising was well underway for the Susan Bulkeley Butler Center for Campus Life (aka "Student Center"). Then coronavirus was introduced into our vocabulary followed by social unrest, widespread natural disasters, and contentious political campaigns.

Through these challenges, the Cottey community demonstrated incredible strength and continued to provide the Cottey experience that makes this college truly unique. At a time when other colleges and universities have struggled with decreasing enrollment and containing COVID rates, Cottey experienced an increase of 10% in overall enrollment and low COVID positivity numbers on campus. Forward momentum was also evident in four capital improvement projects – a new stock trading lab and esports arena, renovations to the main floor of



the library, a new cadaver lab for students entering the medical fields, and start of construction on the Student Center.

This can only be accomplished through the effort and commitment of a very strong team – it's the faculty, staff, students and you, our donors, whose support makes all of this possible, and we could not be more grateful.

The last line of Dickens' tale reads "*It is a far, far* better thing that I do, than I have ever done; it is a far, far better rest that I go to than I have ever known." Through the pandemic and the turmoil of 2020, we continue to be inspired by those around us who give of themselves in support of the Cottey mission. Thank you for helping create incredible futures for Cottey students. It is truly a very good thing.
