Program for Continuing Education

It is that time of the year when we start to focus on our 2021-2022 contributions for the Projects. This year, please consider becoming a "PCE Brighter Tomorrow" chapter. Your chapter can make a lump sum donation of \$500 or more and then be designated as a PCE Brighter Tomorrow Chapter. Another wonderful way to support PCE women is the Joan K. Bradshaw PCE Grant. This is a "named" grant which was established to honor Joan Bradshaw and her work in P.E.O. Joan was a member of Chapter DD, Athens, Ohio. She was President of Ohio State Chapter in 1978-79 and served as International Chapter President in 1987-88. We can honor Joan and her work in P.E.O. by supporting the named grant and at the same time, make a memorable contribution to the education of a deserving PCE candidate.

The Joan K. Bradshaw PCE Grant is \$3,000. A donation totaling \$3,000 can be made by an individual, a chapter, or a group of chapters; therefore, donation amounts can vary. Once the total is \$3,000, the PCE board of trustees will select a PCE named grant recipient from the applicants sponsored by Ohio chapters. Educational Loan Fund

The P.E.O. Educational Loan Fund (ELF) has just released its Statistical Report for the fiscal year ending June 30, 2021. ELF is a revolving loan fund dependent upon the financial support of all P.E.O. chapters.

During the 114 years ELF has been in operation, loans totaling \$231,139,209 have been approved and granted to 50,298 women. Contributions and bequests totaling \$39,174,914 have been received since its inception. These ELF totals are impressive and demonstrate the long-term commitment of P.E.O. to the educational needs of generations of women.

For the 2020-2021 year, ELF has \$47,071,387 in loans outstanding and \$2,413,750 approved for future issue, for a total loan and commitment figure of \$49,485,137.

Ohio had 21 approved loans for \$259,000 in that same period. Only six states had more approved loans and a higher amount approved: California (31), Colorado (32), Illinois (44), Iowa (29), Minnesota (43), and Oregon (30). Ohio local chapters provided \$39,183 in contributions or bequests to ELF in 2020-2021.

Even with these statistics, one of the more frequent questions I hear – even from other state ELF chairmen – is how does one find a qualified ELF candidate? The first step might be to check with your own chapter. Perhaps your chapter's ELF Chairman could present the project at a meeting, using one of the online program ideas. It is then that a member might remember a neighbor whose daughter is graduating from high school or a niece or granddaughter who is struggling financially to complete a degree.

Some chapters near community colleges or universities have established a relationship with an academic advisor who can refer qualified applicants back to the chapter. Perhaps the chapter would like to distribute ELF flyers to nearby educational institutions or potential applicants. The flyers are already available in .pdf form on the P.E.O. International website. Let's carry this story forward!

Amendments and Recommendations Committee

Though we are all praying for pre-pandemic normalcy, our chapter meetings are still following procedures established by P.E.O. International during Covid-19. Please keep this in mind so that you can easily prepare your chapter Bylaws and Standing Rules by the March 10, 2022 due date. If your chapter has not done so already, now is the time to check your chapter bylaws and standing rules, and check them against the following:

- The 2021 Review of Chapter Bylaws and Standing Rules and cover letter mailed to your chapter president last summer with the suggested changes and recommendations implemented.
- Use the Suggested Bylaws posted on the Ohio P.E.O. Website as a guide as well as The Style Guide found on the P.E.O. International website.
- Following the Convention of International Chapter this Fall, all chapters will need to make changes to their bylaws. The change will be in Article I Meetings, to read: "The number of chapter meetings is twelve in a year ... " These changes are to be implemented and do not require a chapter vote. PLEASE change the date at the top of your bylaws to the date the changes were reported.
- Please remember to highlight all changes made to your bylaws before submitting them. Various forms of highlighting include the use of a highlighter, different ink color, italics, bold or underlining. If no changes were made, please indicate that at the top of the document.

Once the recommended changes have been made:

- Report the changes to the chapter's bylaws at the next business meeting. The new date on the bylaws (at the top, in the heading) is the date of the meeting at which the changes were voted upon.
- If you are adding or making changes to your bylaws or standing rules which require a chapter vote, be sure to follow the procedure found in Article V (or VI) of your chapter bylaws.

• The recording secretary then attaches the new bylaws to the minutes of the meeting at which they are read and gives a copy to the president for the President's Book. The recording secretary replaces the previous bylaws in the front of the Recording Secretary's Book. If the chapter's yearbook contains the bylaws, be sure that the yearbook committee has a current copy.

Our heroine now does her part! She completes the application form and provides all the required information to your OS chair by an agreed upon date set *prior to the February 1 submission deadline*. Both your chapter's President and OS chair verify all forms are complete, submitting the *Sponsoring Chapter Information* form, along with the applicant(s) materials to *ohioscholarshipschair@gmail.com* by *February 1, 2022.* Unfortunately, late submissions cannot be considered.

The plot thickens! The OS Committee reviews all applications, making selection recommendations to the Executive Board of the Ohio State Chapter for their approval. A list of scholarship recipients is then sent to the P.E.O. Foundation Board of Trustees, responsible for administering the Ohio Scholarship funds, for their final approval. Now, our heroine(s) must sit tight and wait for the concluding chapter in our story to unfold in the next edition of The Heartline!

The Convention theme in 1971 was "What You Are" and the processional first introduced the costumes of the guards and pages: pastel colored dresses and aprons like those of the Founders. The theme of the BIL banquet was "Our Man in the Moon" and featured red, white and blue décor as a tribute to the Apollo 11 Lunar landing.

What else was going on fifty years ago? Walt Disney World opened in Orlando, FL and the first Starbucks opened in Seattle, WA. Southwest Airlines began its first flights between several Texas cities.

In 1971, the average cost of a new house was \$25,250 and the average annual income for an American was \$10,600. Good thing the price of a gas was 36 cents a gallon and a first class stamp was just 8 cents!

Although many things have changed in the past fifty years, the camaraderie of the P.E.O. Sisterhood has remained a constant.
