## **OHIO STATE CHAPTER P.E.O. SISTERHOOD**



#### OHIO SCHOLARSHIPS HONORARY AND MEMORIAL FUNDS

The following funds, established by Ohio State Chapter or as individual honorary scholarships, are invested and administered by the P.E.O. Foundation in accordance with its published procedures and guidelines. The committee shall select eligible recipients and administer the funds according to each individual fund's request.

### **COTTEY SCHOLARSHIP FUNDS**

The **Frances C. Small Scholarship Fund** was established in 1969 from a bequest given by Frances to her Chapter K, Dayton. The chapter wished that this memorial to her be for scholarships to Cottey College. There is no limit as to the amount or number of awards per year. According to the terms of the original gift, the entire balance is available at any time for grants.

The **Mabel Forsythe Memorial Scholarship Fund** was established in 1973 by a stock gift from her children, William E. Forsythe, M.D. and Jean Forsythe Dye, with income only to be used for the scholarship. Mabel Forsythe was a member of Chapter D, Cleveland, and that chapter may recommend recipients if they should have a candidate. The annual income is to provide a scholarship for a second year Cottey student.

The Verda Marie Stegner Scholarship Fund was established by her Chapter BH, Marietta, in 1991 from Marie's estate for Ohio girls going to Cottey College.

# **COTTEY PREFERRED SCHOLARSHIP FUNDS**

The **Linda Hartford Scholarship Fund** was established in 1991 with the gift presented to Linda Hartford, Chapter ES, PSP, by Ohio P.E.O.s in honor of her six years of service to International Chapter serving on the Finance Committee. It is to be awarded annually to an Ohio woman attending Cottey College. If there are no applicants for Cottey, the funds may be used by an Ohio woman attending any accredited college.

The **Chapter DU**, **Ohio Remembrance Fund** was created in December 2007. At the request of the chapter, the Chapter DU – Joan R. Lawrence Scholarship, established in 1990 with the gift given to Joan Lawrence by her Chapter, DU Chardon, in honor of her year as president of Ohio State Chapter was merged with the Diane Bond Fund, established in June, 2005, in honor of Diane's service as Treasurer of the Ohio State Chapter. It is to be awarded annually to an Ohio woman attending Cottey College. If there are no applicants to Cottey, the funds may be used by an Ohio woman attending any accredited college.

# OHIO STATE CHAPTER GENERAL SCHOLARSHIP FUNDS

The **Chapter CQ**, **Ohio Fund** was established in 1996 by transfer of funds from Ohio Past State Presidents Scholarship Fund. The chapter continues to contribute to the Fund, the interest of which goes annually to the Ohio Scholarships Committee to be awarded according to their guidelines. Chapter CQ is to be informed of the recipient. The **Chapter CV Elizabeth Schaefer/Annabel Zimmers Grant** is a continuing scholarship fund established in 1983 as a memorial for Elizabeth "Sis" Schaefer. In 1992 the name was changed to the Elizabeth Schaefer/Annabel Zimmers Grant when Annabel Zimmers wished to contribute to the existing grant. In 2009, the name was changed to include Chapter CV. The chapter continues to give funds to the grant in memory of Elizabeth "Sis" and in honor of Annabel and Chapter CV, Dayton. The grant is awarded every year to a deserving scholar chosen by the Ohio Scholarships Committee.

The **Dale Wohlers Dunkin Scholarship Fund** was established in August 2007 by Jim and Lois Dale in honor of their daughter, Carolyn Dunkin, Ohio State President 2011-2012 and memory of his mother, Ladie Dale's many years of P.E.O. membership and her father, John F. Wolhers' support for higher education. Annual income is to be used to award a scholarship selected by the Ohio Scholarships Committee.

The **EA**, **Ohio Honorary Fund** was established in 2008. Income from the fund will be used to provide general scholarships. Recipients will be selected by the Ohio Scholarships Committee starting in 2013.

The **Elinor Mann Nursing Scholarship** was established in February 2005 by the grandchildren of Elinor Mann to honor her 90th birthday and 35 year membership in P.E.O. The purpose of this fund is to provide continuing education grants to women living or studying in Ohio who are pursuing an education in nursing. It has been stipulated that if there are excess funds over those needed to give nursing scholarships to applicants in Ohio, grants money should be allocated to other state chapters who have applicants pursuing an education in nursing.

The **Helen Griffith and Isabelle Sinclair Memorial Fund** was established January 2003 by Judy Brown in memory of her mother and grandmother. Annual income is to provide a scholarship to a recipient selected by the Ohio State Scholarship Committee, and Chapter T, Toledo, is to be notified when an applicant is selected to receive this award.

The **Jane Molenar Scholarship Fund** was established with the P.E.O. Foundation on 12/4/2018. The purpose of the fund is to provide scholarships for women, as selected by the Ohio State Scholarships Selection Committee.

The **Jeanne Francy Scholarship Fund** was established in July 1991 with a gift by Louise Neely in memory of her sister, Jeanne Francy, a member of disbanded Chapter AD, Cleveland. The annual income from the fund is to be used to provide a scholarship to an Ohio student.

The **Joanne Glatte Homer Nursing Scholarship** was established in July 2009 by George M. Homer in memory of his wife. Funds will be used to provide a single \$1,000.00 scholarship to residents of Ohio who are studying nursing at a four year, accredited Ohio school.

The Liz Wendelmoot/Maybelle Booth Scholarship Fund was established in February 2005. The purpose of this fund is to provide one or more general scholarships for a female recipient to be selected by the Ohio State Chapter.

The Lois Orr Ohio Scholarship Fund was established in April 2008 by Chapter AM in honor of Lois Orr's board service to Ohio State Chapter. The chapter became Chapter AM-BV after a merger on May 1, 2010. Chapter AM-BV will direct distributions from this fund and has selected the Ohio Scholarships Committee to select recipients. Income from the fund will be used to provide scholarships to female high school graduates.

The **Margrett C. Schultz Memorial Fund** was established in 1984 by the Ohio State Chapter with a bequest from the estate of Margrett Schultz. The annual income is to provide a scholarship for an Ohio woman to attend a school of her choice.

The **Marian B. Moser Memorial Scholarship Fund** was established in 1986 by Chapter BP, Marion, with funds from the Marian B. Moser estate. The annual income is to be used to provide grants to students as specified by the rules of Ohio Scholarships.

The Mary Bennett Hoffman Ohio Scholarship Fund was established.....

The **Mary Hughes Berry Scholarship Fund** was established in 1991, with a gift from Mr. and Mrs. Berry in honor of her many years in P.E.O. and for serving as chairman of the Ohio Scholarships and Grants Committee 1990-1991. The award shall be made to a recipient who will be attending a four-year accredited Ohio college or university.

The **Ohio Scholarship Fund 1** was established as an endowment fund and was initially administered by Ohio State Chapter until 1996 when the Ohio Executive Board voted to transfer the funds to be held in the P.E.O. Foundation. The annual income from this fund is to be administered by the Ohio Scholarships Committee following committee and P.E.O. Foundation guidelines in awarding scholarships.

#### The Ohio Scholarship Fund 2 was established.....

The **Ohio Convention 2000 Fund** was established in February 2001 by the eight chapters that hosted the Ohio Convention 2000 in honor of Grace Chalker, Past President of Ohio State Chapter. The annual income from this fund is split equally between PCE and Ohio Scholarships Fund 2.

The **Ohio Past State Presidents Scholarship Fund** was established following the 1992 state convention with gifts given to Carol Crowe, Becky Henderson Bartter and Jane Molenar and deposited into the P.E.O. Foundation. Gifts given in honor of Jean Couchie Burnquist and Grace Butler have been added. The annual income from this fund is to be administered by the Ohio Scholarships Committee following the guidelines for this project. In the event of the death of a past state president, the scholarship will be given that year in her memory. The committee will annually advise Alexina Circle of the recipient(s) and amount of the award(s).

The **Ruth F. Stamman Scholarship Fund** was established in October 1991 with funds transferred from the estate of Ruth F. Stamman by disbanded Chapter AD, Cleveland. The annual income is to be used to provide scholarships in the name of Ruth F. Stamman to qualified women to attend any accredited college.

The **Winnifred Pixler Grant** no longer exists. The funds were depleted in 2015. This had been established with monies received from the estate of Mrs. Pixler and given through Chapter P, Akron. The interest was awarded every three years from Ohio Scholarships Fund I as specified by the rules of Ohio Scholarships.

## OHIO SCHOLARSHIPS ONE TIME BEQUESTS

One-time gifts and bequests from individuals or chapters given to and administered by the P.E.O. Foundation designating that the Ohio Scholarships Committee select recipients according to the guidelines listed when the fund was opened.

The **Mary Tuthill Memorial Gift** in the amount of \$840 was given to Ohio Scholarships in January 2000. Two-\$420 awards, given in Mary's memory, were given that same year as requested by Mary's chapter, BG.

The Linda Bruck Scholarship in the amount of \$1,000 was donated in January 1999 by various members of Chapter EY in memory of Linda. Two-\$500 scholarships were awarded that same year as requested by the chapter.

The **Paula Wagner Scholarship** was a bequest given to Chapter AE from her estate. The first gift of \$5,000 was given to the P.E.O. Foundation March 2003 and the chapter requested the money be divided into two-\$2,500 awards and used that year. In January 2004 Chapter AE donated \$19,000, plus indicated that an additional gift of a \$1,000 would follow the next year for a total of \$20,000. The chapter requested that eight Ohio Scholarships be initiated in the amount of \$2,500 each. Four scholarships were given in 2004 and the remaining four scholarships were awarded in 2005.

The **Millicent B. Kepke Bequest** in the amount of \$5,000 was a one-time gift to Ohio Scholarships as requested in her will. Millicent was a member of DH Columbus, initiated in 1957, and entered Chapter Eternal January 14, 2003. This gift was sent directly to the P.E.O. Foundation and was dispersed in 2005 in five-\$1,000 awards.
