RULES OF CONVENTION

Admission:

- 1. Delegates and visitors must register before attending convention business meetings. Those participating in the program should be seated in the front before the opening of each meeting.
- 2. Admission to convention shall be by official badge.

General:

- 1. Only registered delegates may be seated at the assigned delegate seats. The chapter letters are visible on each chair.
- 2. If during the course of convention an alternate delegate replaces a registered delegate, the alternate delegate must go through the same registration procedure as the delegate and may only be seated upon unanimous approval of the Chair on Credentials and the Treasurer of Ohio State Chapter.
- 3. Everyone should be seated before the scheduled call to order of each meeting.
- 4. Remain seated during the processional and recessional.
- No one will be admitted during the report of the guards, meditations or musical selections.
- 6. The taking of photographs is prohibited during business meetings.
- 7. All electronic devices, including pagers, tape recorders and cellular phones shall be turned off during meetings.
- 8. Guards and pages will distribute necessary communication except during meditations and the address by the Representative of International Chapter.
- 9. Inability to hear shall be signified by raising the hand.

MINUTES OF CONVENTION OF OHIO STATE CHAPTER Saturday, June 4, 2022

Following the musical prelude, President Janice Hornack called the second meeting of the 94th Convention of Ohio State Chapter to order at 8:33 a.m. Head Guard, Carol Skoglund, Q, gave the report of the guards. Chair of Credentials Committee, Kylie Smith, CU, PSP, gave the second credentials report. Kylie Smith reported 170 members of convention were entitled to vote. Kylie Smith moved that the report be adopted. There being a majority in the affirmative the report was adopted.

The president announced that the annual reports of the officers of Ohio State Chapter are in the convention program book on pages 32-42. She encouraged members to read the important information about what the officers accomplished over the last year. She announced that the officers' written reports were filed with the secretary to be included in the proceedings of convention. The president announced that the reports of standing and project committees are included in the delegate packet. By general consent, the Annual Report of Membership of Disbanded Chapters was not read but will be included in the proceedings of convention.

Organizer Julie Brooks presented the period of instruction provided by International Chapter on the Ceremony of Initiation.

In preparation for the presentation of amendments to the Bylaws and Standing Rules of Ohio State Chapter, the president requested all members of convention to be in assigned seats and asked visitors to remain seated in the area behind the delegates. She instructed the convention in the procedure for presentation of amendments and voting.

The report of the Amendments and Recommendations (A&R) Committee was given by Chair Sue Hamen, AG, who first introduced the other committee members, Carolyn Dunkin, EA, PSP and Beth Selinsky, CX.

The chair presented the 2022 proposed amendments to the Bylaws and Standing Rules of Ohio State Chapter. By general consent, only the explanations of the proposed amendments were read. Page numbers refer to the 2021 printing/posting of the Bylaws and Standing Rules of Ohio State Chapter.

PROPOSED AMENDMENTS TO THE BYLAWS AND STANDING RULES OF OHIO STATE CHAPTER

The following two amendments were considered as a whole.

1. Submitted by the Finance Committee of Ohio State Chapter

(page BL-8) Amend Article VII, by striking out Section 7.

1.A. Conforming Amendment

(page BL-7) Amend Article VII, Section 1, paragraph 2, sentence 1, by striking out the words "and Technology Fund" following the words "International Convention Fund" so that if adopted the paragraph would read:

Twenty-six dollars (\$26.00) for International Chapter dues, which includes six dollars (\$6.00) for Cottey College; ten dollars (\$10.00) for Ohio State Chapter dues, which shall be allocated between the General Fund, State Convention Fund and International Convention Fund. Allocation amounts shall be recommended annually by the Finance Committee with the approval of the executive board and presented to, and approved by, the convention of state chapter.

The amendments were adopted by a two-thirds vote.

Prior to presentation of the following block of amendments, Sue Hamen announced that amendments #7, #8 and #9 were withdrawn by the A&R Committee.

The following five amendments were considered as a block.

2. Submitted by the Executive Board of Ohio State Chapter

(page BL-4) Amend Article IV, Section 6, subsection VICE PRESIDENT, paragraph 4, by striking out the words "Local Chapter Officers Area Workshops" and inserting the words "Local Chapter Officer Training" so that if adopted the paragraph would read:

To conduct Local Chapter Officer Training.

NOTE: If this amendment is adopted, all references to Local Chapter Officers Area Workshop will be renamed to Local Chapter Officer Training in the Bylaws and Standing Rules of Ohio State Chapter to conform.

3. Submitted by the Amendments & Recommendations Committee of Ohio State Chapter

(page BL-4) Amend Article IV, Section 6, subsection ORGANIZER, by adding a new paragraph 9 as follows:

To send chapter bylaws and standing rules of a newly organized chapter to the Amendments and Recommendations Committee.

4. Submitted by the Executive Board of Ohio State Chapter

(page BL-6) Amend Article VI, Section 1, subsection PRESIDENT, by striking out paragraph 1 and inserting a new paragraph 1 so that if adopted the paragraph would read:

To send a letter, approved by the chapter, to the local chapter's executive board contact officer before March 1, reporting the general condition of the chapter. The letter shall be filed in the local chapter's president's box and made available to all members.

5. Submitted by the Executive Board of Ohio State Chapter

(page BL-6) Amend Article VI, Section 1, by striking out the subsection GUARD.

6. Submitted by the Executive Board of Ohio State Chapter

(page BL-6) Amend Article VI, Section 2, by striking out subsection B.

NOTE: If this amendment is adopted, the subsequent subsections will be relettered to conform.

- 7. Amendment #7 was withdrawn.
- 8. Amendment #8 was withdrawn
- 9. Amendment #9 was withdrawn.

The amendments #2 through #6 were adopted by a two-thirds vote.

The following two amendments were considered as a whole.

10. Submitted by the Executive Board of Ohio State Chapter

(page BL-13) Amend Article X, Section 7, by striking out the subsection Membership and inserting a new subsection Membership so that if adopted the subsection would read:

<u>Membership</u>. The Cottey College Committee of one shall be appointed by the president and shall serve two years.

PROVISO: The reduction of members serving on the Cottey College Committee from three to one shall not take effect until 2023; in 2022, a new member shall not be appointed and the committee shall have two members with the senior member in point of service serving as chair; in 2023, a new member shall not be appointed and the committee shall have one member; and in 2024, a new member shall be appointed for a term of two years.

10.A. Conforming Amendment

(page BL-3) Amend Article IV, Section 6, subsection PRESIDENT, paragraph 1, by inserting the word "necessary" following the word "board,"; and by striking out the word "of" and inserting the word "to" so that if adopted the paragraph would read:

To appoint annually, with the approval of the executive board, necessary members to the following committees: Amendments and Recommendations, Finance, History, Membership, Ohio Scholarships, Unaffiliate/Nonresident, Cottey College, P.E.O. Educational Loan Fund, P.E.O. International Peace Scholarship Fund, P.E.O. Program for Continuing Education, P.E.O. Scholar Awards, and P.E.O. STAR Scholarship.

The amendments were adopted by a two-thirds vote.

The following five amendments were considered as a whole.

11. Submitted by the Executive Board of Ohio State Chapter

(page BL-11) Amend Bylaws, by inserting a new Article X as follows:

ARTICLE X CONVENTION ADVISORY COMMITTEE

Sec. 1. COMMITTEE. The Convention Advisory Committee shall consist of four (4) members, appointed by the president, one (1) member to be appointed each year to serve for four (4) years. Not less than one (1) of the members shall be a past president of the Ohio State Chapter, and two (2) members preferably having served as a steering committee member for a state/provincial/district convention. The senior member in point of service shall be chair. The adviser for the committee shall be the current president of Ohio State Chapter.

Sec. 2. DUTIES. The duties of the committee shall be: 1. To assist executive board and co-chairs of the convention committee on the selection of an in-person convention venue and serve as a resource to the executive board and hostess chapters on contract details.

- 2. To maintain a file of in-person convention venue and online registration platform contracts signed by the Ohio State Chapter executive board members.
- 3. To assist the executive board with online platform contract renewal.
- 4. To assist the executive board, OSC Finance Committee, and OSC Executive Assistant with preparing convention budgets and convention worksheets.
- 5. To manage the convention registration.
- 6. To serve as a resource for co-chairs of the convention steering committee.
- 7. To serve in an advisory capacity during convention.
- 8. To recommend updates to the state convention manual.
- 9. To review convention survey results with the executive board.
- 10. To send to the adviser quarterly activity reports, and an annual report of the committee by April 15.

PROVISO: In 2022, the president shall appoint one member to a one-year term; one member to a two-year term; one member to a three-year term; and one member to a four-year term.

NOTE: If this amendment is adopted, the subsequent articles will be renumbered to conform.

11.A. Conforming Amendment

(page BL-3) Amend Article IV, Section 6, subsection PRESIDENT, line 2, by inserting the words "Convention Advisory" following the word "Recommendations" so that if adopted it would read:

To appoint annually, with the approval of the executive board, members of the following committees: Amendments and Recommendations, Convention Advisory, Finance,...

11.B. Conforming Amendment

(page BL-4) Amend Article IV, Section 6, subsection PRESIDENT, paragraph 4, by inserting the words "Convention Advisory" following the word "Recommendations".

To serve as adviser to Amendments and Recommendations, Convention Advisory and Finance Committees.

11.C. Conforming Amendment

(page BL-7) Amend Article VII, Section 4, paragraph 2, by inserting the words "and members of the Convention Advisory Committee" following the words "standing committees" so that if adopted the paragraph would read:

Sec. 4 – COMMITTEE EXPENSES. The state chapter shall pay from the General Fund:

The travel and administrative expenses of the members of standing committees and members of the Convention Advisory Committee, subject to the approval of the executive board; and of the members of special committees when deemed necessary by the executive board.

11.D. Conforming Amendment

(page BL-8) Amend Article VII, Section 6, subsection A, line 4, by inserting the words "members of the Convention Advisory Committee" following the words "standing committees" so that if adopted it would read:

- rooms, meals, and fees of the executive board, members of standing committees, members of the Convention Advisory Committee and the Chair of the Credentials Committee, two platform pages, seven guards, pianist and song leader, chapter delegates;

The amendments were adopted by a two-thirds vote.

At the direction of the A&R Committee, the A&R chair moved the adoption of the following editorial resolution:

Resolved, That the 2022 – 2023 Executive Board of Ohio State Chapter be authorized to correct article and section designations, punctuation and cross-references, and to make such other technical and conforming changes as may be necessary to reflect the intent of Ohio State Chapter.

The editorial resolution was adopted.

Since there was no objection and the addendum had been distributed and no discussion or vote required, the president announced that the addendum is a result of action taken at the 2021 Convention of International Chapter and would not be read but would be included in the convention minutes and the changes made in the next printing and posting of the state bylaws and standing rules.

ADDENDUM

The following changes are to be made in the Bylaws and Standing Rules of Ohio State Chapter in order to conform with the Constitution, Bylaws and Standing Rules of the P.E.O. Sisterhood, as amended at the 2021 Convention of International Chapter. No vote is required by convention.

1. Each s/p/d will replace the word "chairman" or "chairmen" with the word "chair" or "chairs".

All references to the word "chairman" or "chairmen" in the state bylaws and standing rules will be replaced with the word "chair" or "chairs".

2. Each s/p/d shall make provision that convention may be conducted virtually as determined by the executive board of s/p/d chapter, with the consent of and governed by the rules and policies for electronic meetings adopted by the Executive Board of International Chapter.

(page BL-1) Article I, Meetings, Sec. 1 – DATE AND PLACE, will now be stated as:

Sec. 1 - DATE AND PLACE/FORMAT. The state chapter shall convene annually between May 1 and June 10 unless otherwise approved by the executive board, the place to be announced in the previous convention. In case of emergency, the date and place of the meeting may be changed

by the executive board. If determined by the executive board and approved by the Executive Board of International Chapter, the convention may be conducted through the use of internet meeting services.

3. A member or a woman not a P.E.O. desiring to organize a new chapter must secure the consent of the organizer.

(page BL-15) Article XI, Organization of New Chapters, Sec. 1 – REQUIREMENTS, will now be stated as:

- Sec. 1 REQUIREMENTS. The following requirements are in addition to those listed in the Constitution, Part III, Article I. Any person desiring to organize a new chapter shall write to the organizer of the state chapter before any action is taken. No new chapter shall be organized within thirty days preceding convention of the state chapter.
- 4. Each s/p/d shall change the references of local chapter meetings from "regular business meeting" to "regular meeting".

All references to "regular business meeting" will be replaced with "regular meeting" in the state bylaws and standing rules when referring to local chapter meetings.

MOTION TO RESCIND A VOTE OF OHIO STATE CHAPTER

Submitted by the Executive Board of Ohio State Chapter

It was moved by Jane Koch, vice president, and seconded by Julie Brooks, organizer, to rescind the vote on the amendment to the P.E.O. Constitution to allow local chapters the option to conduct virtual and hybrid meetings (Constitution, Part III, Article III – Meetings) which was approved at the 2021 Convention of Ohio State Chapter to be considered at the 2023 Convention of International Chapter.

The motion was adopted.

The president thanked the members of the committee for their work.

President Janice Hornack called attention to the copy of the budget provided each member of convention. She introduced Lyn Wilhoite, DB, PSP, chair of Finance Committee, who in turn introduced the members of the Finance Committee and presented the report of the Finance Committee. The chair moved the adoption of the report. By general consent, the vote was divided into three parts and a majority voted in favor of each of the following: 1) adoption of the budget; 2) transfer of funds; and 3) the remainder of the report.

The president presented a video from International.

The president recognized and thanked Chris Wallace, DP, who is retiring from her job as webmaster of the ohiopeo.org website. The new website was unveiled and presented to convention.

Chapter C\Columbus, 100 years old 1922 – 2022

Chapter C was the first chapter organized in the city of Columbus and the third chapter in Ohio. On Wednesday, May 31, 1922 they gathered at the home of Mrs. Anna Lewis Pike and her mother Mrs. Clara Lewis in the town of Bexley.

The meeting was called to order by the organizer of the Supreme Chapter, Mrs. Belle Musser. She first explained the Objects and Aims of P.E.O. and then read the names of the eight women from five different states that were the first transfers (dimits) to Chapter C: Mrs. Lucy Pike Fassig, Chapter Z\lowa; Mrs. Lucile Lisle, Chapter AC\Oklahoma; Miss May Cartlich, Chapter A\Minnesota; Mrs. Cliffie Cartlich, Chapter S\Colorado; Mrs. Jessie Paddock, Chapter G\Colorado; Mrs. Clyde Fitzgerald, Chapter B\Ohio; and Mrs. Kathleene M. Dickinson, Chapter R\lowa.

After reading the dispensation granted for the chapter, Mrs. Musser initiated the following new members: Mrs. Anna Pike, Mrs. Luciele Le Sourd, Mrs. Francis Ruggles, Mrs. Katherine B. Isry, Mrs. Clara B. Lewis, and Mrs. Alma B. Hamblin.

For Chapter C this beginning has led to many exciting changes through the years. The chapter has been a part of forming new chapters in the Columbus area as well as the formation of Ohio State Chapter. They were involved in forming a state reciprocity committee and hosting conventions. They have even had a member become a state officer. It has been very rewarding to see

the friendships that are present in this chapter. Though their numbers have grown and dwindled and grown again, their most important purpose has been the scholarship recipients. In order to do this they have had many fundraisers from selling peanuts, kitchen metal sponges, magazine subscriptions, cookbooks, fudge, casserole carrying cases, elaborate decorated Easter eggs, Gwen Frostic note paper, and bridge parties and rummage sales. Most recently they have sown aprons and sold Rada Cutlery. The sisters of Chapter C cheer on another 100 years!

Chapter BB\North Canton, 75 years old 1947 – 2022

From the early minutes, this is recorded: "Saturday afternoon, April 19, 1947, at four o'clock, a new chapter of the P.E.O. Sisterhood was formed. The ceremonies took place at the Belden Hotel, Canton, Ohio. This new chapter BB is composed of a group of fourteen representative young women from North Canton, Ohio. Merriam Rohn Beals, the newly elected president, is a niece of Myrtle L. Samblanet, guard of Chapter AC (Canton), who with Lillian H. Bell, its president, was instrumental in forming this new chapter. Esther B. Samuel, Ohio State Organizer from Lakewood, Ohio, conducted the initiation."

The fourteen young women forming the new chapter BB were: Merriam R. Beals, President; Ruth Acheson, Vice President; Marie Roglin, Recording Secretary; Pauline Kolp, Corresponding Secretary; Naoma Sickafoose, Treasurer; Dorothy Ewing, Chaplin; Marie Trout, Guard; Elizabeth Bixler, Dorothy Dively, Lena Witter, Carolyn Krichbaum, Catherine Powell, Kay Johnson, and Esther Warburton. Chapter AC\Canton was the P.E.O. Chapter that sponsored Chapter BB.

The early minutes reflect that in 1951, Canton Chapter AC, assisted by the other three Canton chapters (AW, BB, and BL) hosted the P.E.O. State Convention at the St. Francis Hotel in downtown Canton. Again in 1959, the four Canton area chapters of P.E.O., Chapters BB, AC, AW, and BL, served as hostesses for the State Convention held at the College of Wooster in Wooster,

Ohio. Interesting to note the smaller venues (such as Canton and Wooster) that used to host a State Convention in the 1950s! As a part of their history, Chapter BB was instrumental in the formation of Chapter El\Canton organized in 1981. Another important part of their history is that they have initiated 86 sisters, in addition to our original members, to continue the sisterhood of P.E.O. They are thankful for the message of our star as they celebrate our 75 years!

Chapter BC\Dayton, 75 years old 1947-2022

Chapter BC, Dayton, Ohio, held its organizational meeting on June 27, 1947. The meeting was led by Gladys Tanner, State Organizer, and was held at The Wishing Well, an old schoolhouse which had been converted into what was called a "tea house" in that era. Chapter BC was sponsored by Chapter AK of Dayton with three transferring members- Mary Bolinger, Lucile Romig and Louise Hall. Other transferring members were Frances Smith from Chapter DO and Gertrude Camm from Chapter B. The nine initiates were A. Harriett Park, Dorothy Culp, Madilyn Oenning, Madge Prass, C. Rosalie Arvidson, Gwen Staudt, Helen Hunt, Julie Stutson and Harriett Nutt.

After 50 years as a member of Chapter BC, one of the founding sisters, Dottie Culp, had this to say about her P.E.O. experience: "It's been a real investment for me of time and energy-I've had to make choices- I could have joined more organizations- played more bridge- but the ideals and aspirations have always pulled me back to P.E.O. - to seek growth. The Objects and Aims sum up so succinctly what I felt was important to living my life. Along the way, I've walked with some wonderful women, learned from themloved them. It's been a good 50 years."

Chapter BC is proud to celebrate their 75th anniversary. They have 21 members plus two non-resident members.

Chapter BD\Columbus, 75 years old 1947 – 2022

Celebrating 75 years of Providing Educational Opportunities to Women

On December 6, 1947, Chapter BD was organized in Columbus by Gladys Tanner of Chapter Y. There were 18 charter members with 10 initiates and 8 transfers (dimits). A member of Chapter V opened her home for the chapters' second meeting. One of the founding members, Nadine Mindigo, had moved to Columbus from Deadwood, South Dakota. Nadine was an active member past her 102nd birthday.

By 1955, the chapter had grown to 35 members. In 1969, the chapter changed from only night meetings to both day and night meetings to accommodate more working members. The annual Make-Bake-Grow fundraiser began in 1970 and continued to be a popular tradition until 2020.

Members of Chapter BD have served as Reciprocity Presidents, delegates to the International Convention, hostess chapters to four state conventions, and assisted in the organization of chapters BX\Columbus and FA\Gahanna. Chapter BD has experienced all elements of growth and decline during its 75 years. Our chapter is smaller now with only 14 members. Yet they continue to keep the spirit of P.E.O. alive. Their commitment remains strong as we continue our story forward to the next 75 years.

Chapter DY\Troy, 50 years old 1972 – 2022

Mary B. Whidden moved to Troy, Ohio in 1971. Since there were no chapters in the area, she drove to Dayton every month to visit different chapters. At a Founder's Day luncheon, she was told that there were other P.E.O.'s in Miami County! She was given names and started the process to organize a chapter.

Betty Arnold, Past State President, and Mary Wolfe, Ohio State Organizer, guided the seven founders of Chapter DY through the process of becoming an Ohio Chapter. They met twice a month, kept minutes, had programs, and luncheons for prospective members. DY was sponsored by Chapter CH, Dayton. The Seven Founders of Chapter DY, Troy, Ohio are Winnie Brentliner, Harriet Cary, Margaret Dillow, Lois Gaskin, Mildred Gillam, Dorrie Wilson, and Mary B. Whidden

The organization for Chapter DY was November 18, 1972. It was held at 1 o'clock in the Tipp City Methodist Church. Along with the Ohio State Officers, Margaret's mother, Marian Dickerson, from Indiana and Lois' mother, Lillian Westerberry, from Illinois attended. Mary Wolfe initiated eight new members: Joyce Hansen, Violet Hotzler, Carolyn Miller, Kay Short (Kaebnick), Garnet Simmons, Olive Wright, Cathy Wilson, and Mary M. Whidden (Watson).

Chapter FC\Painesville, 25 years old 1996 – 2022

Susan Doig and Lisa Lutz from daytime chapter AH\Mentor; Barbara Bach and Dina Mutillo from Q\Cleveland Heights; and Beverly Baines, an inactive sister from Wisconsin started meeting informally in November, 1995. In March 1996, Chapter AH\Mentor was given Consent to Select a Charter list. On April 24, 1996 Susan Doig was given permission by Joanne Spratt, Ohio State President to begin officially organizing the new evening Chapter FC in Painesville, Ohio with Grace Chalker as Ohio State Organizer. The chapter's organization was held on April 5, 1997 at the First Presbyterian Church in Willoughby (where BIL Peter Bach was the pastor).

The 14 charter members were: Allison Bach, Barbara Bach, Beverly Baines, Donna Cocozzo, Donna Coon, Pat Dean, Susan Doig, Jan Downing, Ellen Hall, Joyce Kasserman, Lisa Lutz, Dina Mutillo, Shirley Poitras, and Carolyn Wilson. Of the 14 sisters, four were transfer members, one was a reinstated member, and nine were new initiates. These sisters brought a diversity of

interests and backgrounds to FC – several were young mothers with new babies, others were professional women, a couple were doting grandmothers, and one was a mother/daughter combo. Donna Cocozzo is the only charter member still active in Chapter FC.; however, two currently active members have LONG histories with FC. Belinda Torres had participated in the organization meetings, but was unable to attend the organization ceremony as she was delivering a baby! She became the chapter's first initiate on May 27, 1997. Yvonne Laning Oyler served on the initiation team at the organization and for Belinda's initiation. She then became FC's first transfer sister later that same year.

One of Chapter FC greatest strengths has been its commitment to finding candidates for P.E.O. projects – they have successfully sponsored at least 1 PCE, ELF or Ohio Scholarships recipient every year! The chapter enters their 25th year with 14 active members and a 'can-can' attitude to strengthen and grow during this year of chapter revitalization and reorganization.

MINUTES OF CONVENTION OF OHIO STATE CHAPTER Sunday, June 5, 2022

ANNUAL REPORT OF THE STATE AMENDMENTS AND RECOMMENDATIONS COMMITTEE 2021-2022

The Amendments and Recommendations Committee of Ohio State Chapter has had a busy year of meeting both in person and via ZOOM.

Sue Hamen, AG, Chair, met in the beginning of August 2021 with the outgoing chair, Sheryl Dages, DM, and Carolyn Dunkin, EA, PSP, to discuss updates to the notebooks of the chair and first and second year members of the committee. Carolyn Dunkin agreed to make the necessary revisions to the Guidelines and Bylaws Review Instructions for A & R. She also revised the monthly calendar.

Following this meeting, Sue met with our newest member, Beth Selinsky, CX, to provide her with the first-year member notebook and explain a little about the committee and what our tasks would be for this coming year.

On August 25, we met again with our advisors, Jan Hornack and Jane Koch, to discuss Guidelines for A & R committee, Monthly Calendar, review instructions and basically orient Beth to the new committee in more detail. We also discussed what amendments we might expect prior to the December 31 deadline. Jan reported that the Convention Ad Hoc Committee would present an amendment creating a new committee. Finance and A & R were also working on several amendments.

Heartline Articles were written by the chair for both the Fall 2021 and Winter 2022 editions. The fall article revisited the procedures for submitting an amendment to convention of Ohio State Chapter. The Winter Heartline article told of the procedures for submitting bylaws since the Convention of International Chapter, which took place in the fall of 2021, brought about some changes to our local chapter bylaws.

The committee, including advisors, convened again on November 29, 2021. Amendments were beginning to take shape and the committee was tasked with reviewing, rewording, and discussing the amendments that were being presented. We will present 11 amendments at the Convention of Ohio State Chapter in Athens, OH in June. Our International Advisor, Elizabeth McFarland, has been invaluable as a resource for bringing these amendments to our convention. Through 9+ drafts, the committee met on ZOOM to review and make suggestions to the amendments prior to resubmitting them to Elizabeth. This process took us well through January and February.

Local chapter bylaws and standing rules were reviewed by the committee. Completed reviews were filed and the reports were posted to the Google Drive for email distribution to the chapters.

ANNUAL REPORT OF THE STATE FINANCE COMMITTEE 2021-2022

In accordance with the duties defined in the P.E.O. Constitution and the Bylaws and Standing Rules of Ohio State Chapter, the Finance Committee submits the following report:

Reports of state chapter officers and committees containing accounts of receipts and expenditures of state chapter funds have been examined. Monthly financial reports by the Executive Assistant to the Treasurer have been reviewed.

A formal independent CPA audit of the financial records of Ohio State Chapter was performed by Denman & Company, LLP in West Des Moines, Iowa. Denman's formal report will be reviewed by this committee prior to the start of convention.

The budget for the current P.E.O. year 2022-2023, retroactive to April 1, has been prepared after careful study of the receipts and expenditures for the past year and in consultation with state chapter officers. It is submitted to the convention for adoption. The budget consists of two documents, one for the General Fund and one for the State Convention Fund, which brings the budget format for Ohio State Chapter in line with best practices and the recommendation of International Chapter. Copies of the proposed budget have been placed in the convention packets.

The committee recommends that the balance from the Technology Fund for the closed 2021-2022 fiscal year be transferred to the General Fund.

Ohio State Chapter Bylaws provide that the annual state dues of \$10.00 per member be allocated by the Finance Committee and approved at the Convention of Ohio State Chapter. The Finance Committee recommends the allocation per member for the 2022-2023 fiscal year be \$8.00 to the General Fund, \$1.75 to the

State Convention Fund, and \$0.25 to the International Convention Fund for the current P.E.O. year 2022-2023. The executive board of Ohio State Chapter approved the allocation of dues on April 30, 2022.

The Finance Committee expresses sincere appreciation to the state officers and committee members for continuing to keep expenses to a minimum while effectively meeting the needs of Ohio State Chapter.

ANNUAL REPORT OF THE STATE CHAIR HISTORY COMMITTEE 2021-2022

At the virtual 2021 Convention of Ohio State Chapter, incoming President Jan Hornack, Q, encouraged members to honor the history of the past, but create relevance for now and the coming years. This past year, chapters around Ohio did in fact embrace the challenge of *Carrying Our Story Forward*.

Having a year of pandemic-living under their belts, chapters settled into a new normal for meetings, socials, and fundraisers. Chapters reported average meeting attendance ranging from six members to 32, with the average being just over 15 sisters. Zoom was still the name of the game, with a few chapters opting to host nearly 100% of their business meetings in a virtual format. During the summer, lots of in-person meetings took place outdoors with chapters utilizing pavilions and parks. Fall 2021 saw many chapters back in-person, indoors, with various COVID-19 protocols in place.

Programs were sometimes in person, and sometimes virtual, depending on the chapter and the time of year. Topics included: paper flower making, Ukranian egg decorating, chicken raising, cyber safety, musical performances, glass etching, foster parenting, Kentucky Derby hat making, charcuterie boarding, and more than one chapter learning about Ruth Bader Ginsberg.

Social events definitely had a different flavor than those in pre-pandemic years. Some chapters chose to primarily host virtual events such as Zoom BINGO and a "who's who" with pet photos. In-person events occurred indoors and out, and included a Hawaiin Luau, twilight-moonlight hike, game nights, wine and cheese socials, and even an axe-throwing outing with BILs. Several chapters made intentional efforts to socialize in small gatherings, such as Chapter BG's Daisy Circles, Chapter DP's Pix Six Luncheon, and Chapter FI's patio visits with the president.

Many chapters had to pivot when it came to their fundraising efforts, as pandemic protocols prohibited a few fan favorites — such as house tours, bed & breakfasts, and some of the food sales. Oh, but P.E.O.s are resourceful! Chapter AH held an "accessory affair" where members donated gently used jewelry, purses, and scarves for purchase by others. Chapter CQ held a sewing bee to make products to sell. Chapter DU had to forego their traditional pie sale and instead sold daisy socks. Chapters FL and BG, unable to do their much-loved house tour, switched to an extremely successful holiday luncheon and auction. Chapters I and FM set up shop at their local farmers market. Garage sales were the fundraiser of choice for many, talent auctions were successful, and several

chapters opted for some version of the "no work, no bake, no make, no attendance" fundraiser.

Across the board, chapters spoke highly of the encouragement they have received from the state officers during these pandemic years. Many local chapter presidents, and in fact entire slates of officers, remained in their positions during the past couple of years and have expressed appreciation for the way the state board has been innovative and supportive, even being able to conduct state visits in virtual fashion. They gave high praise for the virtual events that members have been able to attend, including last summer's Convention of International Chapter and last year's Ohio State Convention. The home chapters of each of our Ohio State Chapter Executive Board members are beyond proud of their sisters who are serving at the state level.

Just like Chapter BQ learning to do the Opening Ode in American Sign Language, Ohio P.E.O.s have all learned new skills this past year, keeping the Sisterhood relevant while honoring the past and *Carrying Our Story Forward*.

ANNUAL REPORT OF THE STATE CHAIR UNAFFILIATE/NONRESIDENT COMMITTEE 2021-2022

The purpose of the Unaffiliate/Nonresident (UN/NR) Committee is to identify and contact unaffiliated P.E.O. 's living in Ohio, and Ohio women who have been recommended as potential members of the Sisterhood. The 2021-2022 year

was the first under the new processes developed by the ad hoc UN/NR Committee. The size of the Committee expanded from one member to three. Our primary objectives are to contact Unaffiliates and Friends Recommended residing in Ohio in a timely fashion, assist those women in finding a chapter that best suits their needs, and maintain consistent contact with the women who remain unaffiliated for a longer period of time. Below is a summary of our work this year:

- ★ Reports of all Unaffiliates and Friends Recommended were sent to individual Reciprocities, Regions and Chapters as requested. Each Chapter President was also provided with a report for their respective Reciprocity or Region shortly after the close of Convention of the OSC in June 2021. This communication also contained a sample report in the newly-revised structure, and information concerning the manner in which the UN/NR Committee would be modifying their practices.
- ★ The Ohio UNNR Log was modified to better suit the needs of Chapters and Reciprocities. This included a detailed review of each record to remove those sisters who have become inactive, transferred into a Chapter, or entered Chapter Eternal, resulting in a reduction of several records.
- ★ Quarterly reports from International containing women suggested as potential members to the Sisterhood and women who have inquired via the website were reviewed, and these names were added to the UNNR Log as required.

Additional Initiatives:

- ★ Developed an Excel workbook to allow for specific determination of Chapters based on member ZIP code concentration. Reports providing mapping of chapter members by ZIP code were also produced upon request.
- ★ Reviewed Chapter Yearbooks to see if any unaffiliated sisters should be included on the UNNR Log.
- ★ Submitted two *Heartline* articles focusing on items pertinent to UN/NR activities.
- ★ Sent a post-Convention communication to all Unaffiliates with an Ohio update. The Committee also sent birthday greetings and P.E.O. Anniversary recognition to these Unaffiliates.
- ★ Assisted Reciprocities by updating their information on the Ohio P.E.O. website as requested.

Meeting Attendance:

- ★ Attended the Convention of the OSC in June 2021 and the Leadership Meeting in August 2021.
- ★ Participated in presentations to the SE and SW Quadrant Membership Workshops.

During the past year, the Ad Hoc UN/NRCommittee has assisted in placing upwards of forty Unaffiliates and eight Friends Recommended into their new P.E.O. chapters.

Thank you to the Reciprocities, Membership Committee, Executive Board and Ohio sisters for their continued efforts and assistance in support of our Unaffiliate sisters. Your contributions are vital to this Committee!

ANNUAL REPORT OF THE STATE CHAIR COTTEY COLLEGE COMMITTEE 2021-2022

As this committee focused on *Carrying Our Story Forward*, they encouraged the chapters throughout the state to seek prospective Cottey students within their families and community. Currently, there are three Cottey students from Ohio who plan to return in the fall and five additional young women have been accepted to enroll as freshmen.

Included as part of their tuition, sophomore students safely traveled to Paris, France over spring break for their International Experience with faculty and staff.

This year's Commencement took place in-person on May 15th. The ceremony was live-streamed for those who were unable to attend.

In addition to the articles this committee submitted for the fall and winter editions of The Heartline, several Cottey College newsletters were sent to the Reciprocity Cottey chairs and the Cottey chairs of chapters not affiliated with a Reciprocity Group. This communication helps all Ohio P.E.O.s to be kept informed about "everything Cottey".

In 2021 Cottey College informed the committee that it had been twenty-four years since the bedrooms in the Ohio Suite had been refurnished. There were many Ohio chapters and individual sisters who enthusiastically stepped up to meet the challenge of raising the \$15,000 needed for this project by January 1, 2022. The refurbishment of the bedrooms was originally scheduled to take place this summer; however, due to a delay in delivery of the items and the difficulty of making these changes during the academic year, the new furnishings will not

be completed until Fall 2023. Along with Cottey's recent installation of air-conditioning in Reeves Hall, the Ohio Suite students are sure to love their new surroundings.

Cottey recently approved plans to create an education lab to help students become successful K-12 teachers. This new learning center will be located in the lower level of the Ross Library. It will have three distinct spaces to promote formal and informal learning: a mock classroom, a resource room, and education faculty offices. Dr. Jann Weitzel will officially retire as the president of Cottey College on June 30, 2022. During a celebration the end of April, the Cottey Board of Trustees shared a special SURPRISE announcing the new learning center would be named, *The Jann Rudd Weitzel Education Lab*, in honor of her lifelong passion for education. The total cost to create the lab and establish an endowment fund to create ongoing costs is \$225,000. Cottey has already received a very generous gift of \$75,000 for furnishings, technology, and supplies. P.E.O. chapters and individuals can contribute towards this project by sending their check to Cottey College, Office of Institutional Advancement, 1000 W. Austin Blvd., Nevada, MO, 64772, and indicate it is a gift for the education lab.

Many thanks to committee members, Kathy Calabrese, Siobhan Smith and OSC adviser, Jane Koch, for their willingness to help this chair and for the time they spent sharing information about Cottey with others.

ANNUAL REPORT OF THE STATE CHAIR P.E.O. EDUCATIONAL LOAN FUND 2021-2022

The P.E.O. Educational Loan Fund (ELF), founded in 1907, is the oldest P.E.O. project supporting women's educational goals. Maximum loan amounts this year are \$12,000 for a non-degree accredited program, an associate or bachelor's degree; \$15,000 for a master's degree; and \$20,000 for a doctoral degree.

The Ohio Annual ELF Report shows seventeen women were awarded ELF loans between March 1, 2021 and February 28, 2022 for a total of \$231,000 for Ohio. Ohio sponsoring chapters were: AB, AK, AR, BA, BQ, CN, CQ, DB, DP, ED, ES, EX and FI. Chapter BQ sponsored three women, and Chapters DB and FI each sponsored two. Seventeen loans were repaid in full between March 2021 and February 2022 for a total of \$220,000.

Legacy Chapters for ELF were established in 2020. That distinction is given to a chapter with lump sum gifts of \$500 to ELF to increase the amount of funds available. Ohio chapters were very generous in giving to ELF this past year, and several became Legacy Chapters: L, O, Q,

AA, AB, AE, AG, AH, AM-BV, AR, AU, AY, BF, BG, BQ, BW, CE, CH, CQ, CY, DB, DG, DH, DO, DP, DQ, DT, DY, EE, and FL.

This chair was able to participate in the Ohio State Chapter virtual convention in the spring of 2021. Two *Heartline* articles were written and regular activity reports were provided to the state board. Inquiries by phone and email from Ohio chapters were researched and responded to as needed. Chapter efforts to identify, interview and sponsor candidates are truly impressive. This chair appreciates the helpfulness of the Ohio State ELF advisor Rebecca McClelland, the Project Supervisor Stephanie Halton, and Educational Loan Supervisor La Cathi at International.

The 2022 State Convention will be held at Ohio University in Athens, and the daughters of Ohio State President, Jan Hornack, will speak at the Projects Lunch as past ELF recipients. We are encouraged that ELF continues to be "Carrying Our Story Forward" even during these unprecedented times.

It has been a singular privilege to serve as ELF chair again this past year. It is rewarding to see the concern and love extended by our sisters to help others reach their educational goals. Because my only granddaughter was a past recipient, I have a personal appreciation of the impact ELF has on lives.

ANNUAL REPORT OF THE STATE CHAIR P.E.O. INTERNATIONAL PEACE SCHOLARSHIP FUND 2021-2022

Perhaps more than ever in recent years, the dedication and generosity that nourishes each one of our P.E.O Projects offer the world a beacon of hope and optimism for the future. P.E.O.'s International Peace Scholarship Fund, established in 1949, provides scholarships for women from other countries who are pursuing graduate study in the United States and Canada. When they return home to pursue careers, they will not only be carrying their own story forward, but will also be carrying our P.E.O. belief that education is fundamental to global peace and understanding.

In just the past year alone, IPS has awarded 1.8 million dollars to 163 recipients! These women have come from all corners of the world (63 countries in total),

and their majors are as diverse as their places of origin. Our current recipients join the more than 6,500 women since the project's founding to benefit from the IPS Fund.

When a chapter makes a minimum donation of \$500 to IPS, and submits a "Partners in Peace" form to the s/p/d treasurer before the deadline of January 31st, they will be matched with an IPS recipient. The encouragement and support from PIP chapters, in the form of notes, emails, and invitations to chapter socials, means a great deal to IPS recipients far from home.

Internationally, 786 chapters were Partners in Peace in 2021-2022, an increase from last year! P.E.O.s have responded to the need for higher education that recent years have made acute. Seven IPS recipients have been studying here in the state of Ohio, at six different universities. Warm recognition and thanks go to our wonderful Ohio PIP Chapters for supporting IPS! Thank you, Chapters L, AB, AE, AG, AH, AI, AU, AV, BG, BQ, CH, CN, CQ, CS, CY, DG, DL, DO, DP, DQ, DR, DU, DV, DY, ED, EE, EF, EG, EJ, ET, and FI.

Additionally, Ohio is one of only three s/p/ds to have an IPS Named Scholarship donor! A donation of \$12,500 to the P.E.O. Executive Office, and completion of the IPS Named Scholarship form, covers an entire scholarship amount for one IPS student. We are most grateful to Chapter AF for their generous support of the Marian K. Hume International Peace Scholarship!

This chair never ceases to be amazed at the quiet and meaningful difference the P.E.O. projects are making in the lives of women. The time and effort our sisters provide to their local chapters have a profound impact on the health of every project. This chair has been grateful for the kind support and assistance of the executive board, the project supervisor of IPS, and the IPS chairs in each chapter. Thank you to all who have graciously supported IPS, and are carrying our story forward around the world!

ANNUAL REPORT OF THE STATE CHAIR P.E.O. PROGRAM FOR CONTINUING EDUCATION 2021-2022

As the 2021 year ends and a new year begins, this chair finds everyone a bit more relaxed and certainly hopeful that sisters can move forward with their projects and chapter events. Only recently have colleges and universities relaxed restrictions and brought more students back to campus. But the uncertainty of Covid-19 has still had a definite impact on scholarship applications and women's decisions to return to academic pursuits. Hopefully, this coming year

will see an increase in activity and scholarship and in chapters' ability to meet and support deserving candidates.

Ohio chapters successfully supported 12 candidates for the PCE scholarships this year. A total of \$27,400 was awarded between March 1, 2021, and February 28, 2022. The number of successful candidates is less than last year, but the amount of the scholarship awards is proportionately greater, so that is good news. Congratulations to chapters J, AH, CB, CH (2), DL, DY, DZ, EK, EO, and ER. These chapters managed to find and support candidates for the PCE scholarship. This chair is certain that functioning under Covid-19 restraints and conditions was not an easy task. This chair truly appreciates the time and dedication required to help these women pursue their goals. Thank you!

This chair received 13 P.E.O. Program for Continuing Education Potential Applicant forms forwarded by the International Program for Continuing Education Supervisor during the past year. A minimum of 26 chapters in the geographical area of the applicant's home or institution were contacted. Chapters are not required to contact applicants, but this chair is aware of contacts made by multiple chapters. She is encouraged to know that chapters are very responsive to a potential candidate and focus on helping whenever possible. At least three of the potential applicants were not only supported by a chapter but received a substantial award. This chair recognizes the importance of the Potential Applicant form and has talked with chapters about contacting local institutions to add P.E.O. information to their financial aid websites.

One of those women who found PCE scholarships online and submitted the Potential Applicant form will be the PCE speaker at convention this year. Alissa Kirk received the full scholarship amount in 2017 and was able to complete her associate degree. Alissa was sponsored by Chapter DL, Newark, and it has been this chair's pleasure to work with Chapter DL and Alissa preparing for the convention.

This chair is so pleased to report that 49 chapters have been designated as "Brighter Tomorrow Chapters" for 2022. This means that each chapter gave \$500 or more to the PCE Scholarship Project. From the "Brighter Tomorrow Chapters", over \$32,000 was given to the project. This chair is hopeful that more chapters will join the 49 and make an even bigger impact next year in supporting PCE and the deserving women it supports. This chair would like to thank all chapters that supported and participated in the PCE Scholarships this year. It has not been easy to have fund raising events nor bring potential candidates into chapters. There is a strong commitment on the

This chair is honored to be a part of the ongoing mission to support women in education and has had the pleasure of talking with very dedicated and determined sisters who also know and respond to the need. ANNUAL REPORT OF STATE CHAIR P.E.O. SCHOLAR AWARD 2021-2022

"Carrying our Story Forward", the theme set by P.E.O. Ohio State Chapter President, Jan Hornack, gives the opportunity to not only look forward but to look back as well. Since PSA's inception back in 1990, it has awarded \$30,250,000 (yes that's millions) to over 2,630 doctoral students. Looking back gives the momentum to look forward with a deep sense of accomplishment and pride.

Presently in Ohio there were 21 PSA nominations submitted by 10 chapters. In addition, there are other options besides nominating a deserving candidate. By donating \$500 to PSA, one can become a Laureate Chapter. The following Chapters need to be acknowledged and commended for their contribution to the Scholar Award and are Laureate Chapters: I, L, Q, AB, AE, AG, AH, AM-BV, AR, AU, AV, BC, BG, BQ, CE, CH, CL, CP, CQ, CY, DB, DG, DH, DL, DO, DP, DQ, DR, DT, DU, DY, EB, EE, EF, EG, ET, EZ, and FL. Because Laureate means "worthy of the greatest honor or distinction", it is a fitting descriptor for participating chapters. Thank you to all the above Laureate Chapters!

Communicating with local chapters through email, text, and phone calls to answer questions and give guidance was rewarding. *Heartline* articles and periodic activity reports were provided to the state board advisor. ANNUAL REPORT OF THE STATE CHAIRMAN P.E.O. STAR SCHOLARSHIP 2021-2022

The P.E.O. STAR Scholarship is in its 13th year of helping high school seniors prepare for their entry into university; the scholarship remains at \$2,500 per recipient. Local chapters have 3 opportunities to go above and beyond when contributing to the STAR Scholarship: Named STAR Scholarships, Endowed STAR Scholarships, and STAR Constellation chapters.

It was another milestone year for the STAR Scholarship as 900 STAR Scholarships were awarded (including 42 Named and 2 Endowed STAR Scholarships)! There were also 1,168 STAR Constellation Chapters. Ohio State Chapter can proudly boast that we had 23 recipients of the 51 women nominated. We also had 39 chapters become STAR Constellation Chapters (an increase of 11 chapters from last year)!

Thanks to Ohio STAR Constellation Chapters: Q, U, Z, ZB, AE, AG, AM-BV, AR, AU, AY, BC, BD, BG, BQ, BX, CE, CH, CL, CP, CQ, CY, DB, DG, DH, DN, DO, DP, DQ, DR, DT, DU, DY, EB, EE, EK, ES, ET, EZ, and FL

The chairman wrote two *Heartline* articles this year regarding the STAR Scholarship. Each year, we get more comfortable with the technology during the nomination time frame and have fewer glitches and challenges. It remains the chair's pleasure to assist chapters however possible to make sure the nomination process is smooth. While helping respond to questions, the chair got to hear about several of the women who were nominated for STAR Scholarships. The diversity in candidates that our chapters find is remarkable. It is a privilege to hear their stories and to be privy to the efforts our chapters take to identify, interview, and submit the sponsorship forms.

The 2022 Ohio State Convention will be in Athens, Ohio this year and we are THRILLED to have an in-person projects display. We will be highlighting the STAR Scholarship recipients as well as Constellation Chapters. We will also hear from Sophie Fulkerson, an Ohio STAR Scholarship recipient about how the

STAR Scholarship helped her get ready for her freshman year at university. While we are grateful that we were able to connect virtually for convention during the COVID-19 pandemic, we are ecstatic to be gathering in-person to celebrate the incredible work being done across all the chapters in Ohio and to inspire and cast vision for the year ahead.

The chair wishes to thank her advisor, Becky McClelland for her endless support this year, especially in the last couple months as we juggled STAR Chair responsibilities with the organization of a new chapter: Chapter FO, North Ridgeville. It is a privilege to serve at the state level and to be a part of growing the sisterhood at the local level.

The STAR Scholarship is unique in that it plants the seeds about the value and importance of P.E.O. before most women are eligible (by age) to join the sisterhood. Identifying and nominating young women for this scholarship is truly a gift. We get to meet brilliant, confident, creative, ambitious, and generous women who have incredible potential to be great P.E.O.s in the future.

It is a privilege and honor to serve the state as the chair for the STAR Scholarship Committee.

ANNUAL REPORT OF THE STATE CHAIR OHIO SCHOLARSHIPS COMMITTEE 2021-2022

The year for Ohio Scholarships Story began with conversations outlining the overall purposes and processes. Given the ongoing Covid situation, the committee met just once in person in the summer to connect with each other and tell our own stories. Zoom meetings then ensued, including attending the August Leadership Workshop. The Ohio Scholarships story was carried forward by discussions within our own chapters as well as articles submitted to the Heartline newsletter.

Ohio's chapters cooperated with the instructions about submitting online applications. The first application arrived in early November 2021 and the final one arrived on February 1st, 2022. While that process may have caused some initial questions and concerns, the result was that 60 chapters submitted a total of 183 applications, with an average of 3 per chapter. This did represent a 20% decrease in the number of chapters submitting applications. The 183 applications reflected a 13.7% decrease from the previous year. The committee was surprised at both decreases. Among those applicants, 35% were high school seniors and 65% were in post-secondary programs. Awards were granted to 134

recipients, 6 of whom are or will be attending Cottey College. It should be noted that the amount of available funds, \$78,248, was a 16.9% decrease from the previous year. While the number of chapters participating, applications and the amount of available funds were all less, the Ohio Scholarships committee was pleased to report that 73% of those who applied received an award, with the average amount being \$584.00.


Beyond the numbers involved, the individual stories told by each applicant helped to remind the committee of the reason for the efforts of Ohio Scholarships. The essays were as varied as each storytelling student. Some described encountering major hurdles in life, language challenges, family or personal health concerns, financial struggles within the family, and some the normal angst of who they are and where they want to go in life. Almost all mentioned the impact of Covid on their educational journey- the interruptions in routines and what they have learned from the communal experience. They expressed a desire to make a difference in life. The Ohio Scholarships committee was moved and impressed by these young women's stories as they move forward.

Covid continued to play a part in the story of Ohio Scholarships as well. Prior to Covid, the committee had gathered for a 3-day, 2- night retreat in February. This year they met via Zoom. The evaluation and selection process were completed on several afternoon and evening sessions. The chair and adviser met over two days in person to determine the award amounts,

Thank you to the Ohio Scholarships committee members Nancy Bubenzer and Tuta Ionescu, and to our adviser Jane Koch. Their loving support, problemsolving skills, computer expertise, sense of purpose, compassion and humor has been deeply appreciated as this chair closes in on the final chapter of this year's Ohio Scholarships story. It has been a pleasure and an honor to serve on this committee and be part of the P.E.O. Sisterhood.

Good evening, Sisters! How wonderful to be together to celebrate our Sisterhood in Ohio!

During this year, Our President, Jan Hornack, has encouraged us to carry our P.E.O. story forward. Think with me about the stories of some historic women who are examples of the virtues which we seek to embody in our P.E.O. experience. Perhaps they will offer us direction for our work together.

Before our initiation, we each declared that we, P.E.O.s are women of FAITH. One of the many biblical women who inspire us is Priscilla. She dedicated her whole life to the practice of her faith. She did not compartmentalize her faith and her work with her husband Aquila. They lived in Rome until 49 A.D. when Roman Emperor Claudius issued an edict banning Jewish assemblies in Rome. Jews and Christians were forced to leave Rome in order to be able to gather for worship. Priscilla and Aquila moved to Corinth and later to Ephesus where they supported themselves weaving goats' hair and sewing tents. They were both from families of financial means and thus, were well educated. They spent their whole life together taking risks, practicing the trade they knew and sharing their beliefs with others. In order to move forward, P.E.O.'s have to utilize the educations that we have been given, to use the tools we have at hand and be willing to take risks to share our faith.

Many of you know the story of Ruth and Naomi. Naomi was Ruth's Mother-in-Law. Their loving bonds were so strong that in spite of their different cultures, they stayed together through the loss of spouses and many other challenges. Their story gives us courage to love one another as Sisters, daughters, daughters-in-law, mothers, grandmothers, aunts and friends. A loving concern is not only our calling for each sister. But a loving concern for the world is the yoke we wear as people of LOVE who move forward with compassion.

Our film culture has influenced little girls to want to become Disney Princesses. Royal Watching is a favorite sport of the media, and many among us! Certainly, the celebration of Queen Elizabeth II's 70 years on the throne of Britain underscores the devotion and the perseverance required to be a leader with longevity and impact.

I want to turn our attention to a royal lady whose story is filled with wisdom and courage. Her PURITY of purpose allowed her to be the leader for a very important time in history. Queen Esther became Queen of Persia, not only for her physical beauty but also for her good mind, kindness, and teachable spirit. In

the crisis that followed, when her Jewish people were threatened, she put herself in potential peril, went before the King and asked for the safety of the people. She was able to rise above all thoughts of herself and seek the common good. She taught us that leadership is about discerning the right time, embracing a pure spirit and being steadfast in our responsibilities as we trust in the future.

Indigenous women of the Maskoke People speak of the injustices done to their people. These range from displacement and genocide to negative stereotyped imagery in media and sports. Thankfully, the Cleveland Guardians have addressed one of these long overdue issues in our midst. Still, our Native American brothers and sisters are plagued with high rates of drug abuse, domestic violence, alcoholism and suicide. Life is not JUST when it is JUST for some, but it must be JUST for all. The gun violence in the news this week has heightened our desire for a new movement forward toward a civil society that is able to protect its children and others who are vulnerable.

Micah 6:8 - calls us "to do JUSTICE, and to love kindness, and to walk humbly with your God." We P.E.O.s, who claim to be educated women, cannot put our head in the sand when we are faced with SO many injustices before us.

TRUTH becomes evident to us in many ways. Some of you may have seen the recent movie, "Belfast", which shared the portrait of one family during that city's conflicts. Last October, it was my privilege to be in Ireland with a tour group of 18 people. While in Belfast we witnessed the wall filled with graffiti which still stands between the Protestant and Catholic Communities of that city from "the Troubles" 30 years ago. I took a number of pictures of the graffiti that spoke to me. One I came across recently said this: "Now is a time to put your feet down differently and look forward." simply signed "Beth".

Wherever there is conflict, whenever there is injustice and struggle, whenever we take on new challenges, we P.E.O.s can set the direction in our homes, in our communities, in our Chapters, in our houses of worship and at our places of work by the direction of our feet. May we never be afraid to "set our feet down differently". For on the horizon, the great expectations of TRUTH that we seek may be fulfilled.

Let us pray,Most gracious and eternal God, we pause in conscious recognition of your Presence with us. We come together for this annual gathering with hope that we shall write a story that moves us forward into new avenues of service and education for ourselves and others. As we live the next chapter of our Ohio story, give us openness to diverse people who join us along the way. May the virtues of P.E.O. - FAITH, LOVE, PURITY, JUSTICE and TRUTH - keep before us the light of our Star that illuminates our paths. Help us to glean wisdom from the stories of our foremothers and forefathers. May we be your people and your leaders for such a time as this. AMEN.
